The purpose of your role

Under the direction of the Innovation Manager, the Senior Innovation Technologist will support in the launching & evaluating of new & existing products in the following categories (yogurt, ice cream, desserts, savoury & fruit) depending which site the role will be based at.

The role will work closely with cross-functional teams to assist in the delivery of cutting-edge, high-quality product concepts. Main areas of focus are:

- ♥ Supporting Innovation Manager in concept creation
- ♥ Improving raw material and packaging knowledge
- ♥ Product formulation knowledge across multiple categories.

Key responsibilities:

♥ **Product Innovation Support**

To assist in the delivery of development projects from Gate 0- Gate 2. Assist in the co-ordination, production and delivery of kitchen samples. Liaising with existing suppliers for new ingredients within a set list of parameters. Demonstrate scientific understanding of the recipe formulation and the roles of the ingredients and impact of the process.

Collaborate with Process Development teams to identify opportunities for process improvements and EPD modifications.

♥ **Customer Engagement**

Support with customer engagement and supporting customer presentations.
Support in the arranging of customer lunches and displays.

♥ **Market Trend Support**

Conduct market reviews & product benchmarking to analyse competitor products to help identify new trends, opportunities and insights.

♥ **Cross Functional Collaboration**

Work with the stakeholders to ensure buy-in of new concept ideas and products to deliver "First to Market" innovation ideas

General Profile:

The Senior Innovation Technologist will be supporting product innovation within Yeo Valley's yogurt, ice cream, dessert, savoury & fruit product lines. This role requires practical knowledge in development, alongside a understanding of related disciplines such as process innovation, technical development, and production. This role will be responsible for generating new concepts aligned to Yeo & Customer briefs. Working with minimal supervision, they will independently address innovation challenges and may take the lead on specific aspects of projects or trials within larger initiatives

Business Expertise: The Senior Innovation Technologist has a good grasp of industry best practices in concept development and understands how their work integrates with cross-functional teams including Process, Technical, and Production. They are familiar with the competitive landscape and aware of factors that differentiate the company's products in the market. The Senior Innovation Technologist's ability to understand both the technical and commercial aspects of the business will be critical in driving product success and ensuring that Yeo Valley's products are competitive.

Leadership: While the primary responsibility will be hands-on kitchen concept work, the Senior Innovation Technologist can lead smaller-scale briefs, coordinating efforts within a team to meet specific objectives. The role requires them to identify technical and operational challenges, apply innovative solutions, and recognise how these decisions affect the broader product development process.

Impact: Guided by department policies and overall product development plans, the role will impact a wide range of process, sourcing and technical activities within the team and across related departments. By generating
